ITEM #1 – WYANDOTTE COUNTY SHERIFF'S OFFICE INMATE HOUSING CONTRACT

Will Johnson, County Administrator, came before the Board for approval of a modification to the existing contract with Wyandotte County for the housing of inmates at the Butler County Jail. Revenue housing of inmates is a means to offset the operational expenses of the Butler County Detention Center. The Butler County Sheriff's Office has housed inmates from Wyandotte County in the past with success. The impact would be an additional ten inmates at \$40 per day which would be an additional \$400 per day and \$3,500 per month.

ITEM #4 – LIQUID ASPHALT BID OPENING

Darryl Lutz, Public Works Director, came before the Board to receive and open liquid asphalt bids for the Highway Department. The Public Works Department purchases 600,000 to 800,000 gallons of liquid asphalt each year for asphalt road maintenance work and for the annual chip seal program. In the past, price quotes were solicited from two local distribution terminals in El Dorado. As of 2004, only one liquid asphalt terminal is still in operation locally. Since 2004, other terminals outside the El Dorado have been solicited for submitting price quotations for liquid asphalts. Following are the bids received:

ITEM #6 – PRE-CAST CONCRETE BOX CULVERT SECTIONS – SW 210^{TH} ST. ENTRANCE PROJECT

Darryl Lutz, Public Works Director, came before the Board to receive sealed bids for the purchase and delivery of pre-cast concrete box sections for a culvert replacement project in Butler County. In conjunction with this year's culvert letting program, staff proposed to reconstruct an entrance with a new properly sized drainage structure that serves two properties on SW 210th St just west of Eightmile Creek. The County is building a waterway to correct a drainage problem that was created many years ago as part of a major bridge and approach roadway improvement project on SW 210th St. The proposed pre-cast concrete box will be large

enough to carry ditch water east to the creek and prevent the water from cutting across productive farm ground. Following are the bids received:

ITEM #7 – GROUNDWATER MONITORING PROGRAM, ANNUAL PROFESSIONAL SERVICES AND LEACHATE RECIRCULATION LINE EXTENSION PROJECT – BUTLER COUNTY LANDFILL

Darryl Lutz, Public Works Director, came before the Board for approval of separate agreements for engineering services related to the landfill for semi-annual groundwater monitoring work, for annual on-call general engineering services and for a planned extension of leachate recirculation lines. The Butler County Landfill programs funds each year for required semi-annual ground water sampling, analysis and reporting work, for annual miscellaneous engineering services primarily related to air permit reporting requirements and technical support for landfill operations and for planned major improvement projects which this year includes the planned extension of leachate recirculation lines into Area 2B. Butler County utilizes the firm of Burns & McDonnell Engineering Company to provide engineering services for the proposed work.

Commissioner Masterson motioned to approve three separate agreements for engineering services provided by Burns & McDonnell Engineering Company in the not to exceed amount of \$125,364 for 2018 through 2020 semi-annual groundwater monitoring work at the landfill, for 2018 miscellaneous on-call engineering services in the not-to-exceed amount of \$30,000, and in the not-to-exceed amount of \$45,776 for all phases of engineering work for the extension of leachate recirculation lines in Area 2B and the proposed construction of a new access road and authorized the Chair to sign said agreements. Commissioner Murphy seconded the motion. Motion carried 5-0.
